#### Acceptance Guidance & Definition CONSTRUCTION & DEMOLITION DEBRIS (C&D)

IS	IS NOT
Bulky debris that is not recyclable	Asbestos - (prior approval necessary)
Painted, treated, or coated wood	Household (kitchen & bathroom) garbage
Wall coverings – Plaster, Drywall, etc.	Recyclables – (recycle !!)
Styrofoam – and other bulky packaging	Batteries – (recycle)
Plumbing fixtures	Cardboard boxes - (recycle)
Non-asbestos insulation	Freon containing items- refrigerators, dehumidifiers, &
Windows & siding	AC units (recycle)
Roofing shingles and other coverings	Appliances - (bulk metal recycle)
Plastic and other non-metal pipe	Tires - (remove from rims & recycle)
Plastic and vinyl sheeting	Fuel tanks - (empty, cut both ends & bulk metal recycle)
Floorings and Carpeting	Electrical wire – (cut and recycle as scrap metal)
Hoses and tubing	Propane tanks- (remove valves & bulk metal recycle)
Tarps and Bale wrap	Liquids or chemicals of any kind – (Clean Sweep)
Fiberglass and plastic vehicle body parts & cabs	Paint – (Clean Sweep)
Unusable clothing	Fluorescent lights, mercury, sodium lights (Clean
Luggage	Sweep)
Furniture	Ballasts, transformers (Clean Sweep)
Unusable large toys	Clean wood – (ask for disposal location)
	Burn barrels or ash (not accepted)

C&D debris is subject to a \$95 per ton disposal fee. Disposal fees are payable by prepaid account, cash, or credit.

#### ANTIFREEZE, MOTOR OIL & OIL FILTERS

No Fee



- 5-gallon limit.
- Gasoline mix or break fluid NOT accepted.
- Residential "Do-It-Yourself" only
- Check with attendant for disposal location

#### **BATTERIES - AUTOMOTIVE & HOUSEHOLD**

No Fee



- Wet cell and dry cell batteries (includes car, motorcycle and boat batteries, 9V, D, C, AA, AAA, button & lantern batteries).
- Check with attendant for disposal location

#### No Fee



#### GRASS CLIPPINGS, LEAVES, BRUSH, and TWIGS

- MUST be in Clear Bags.
- Place with Garbage for Composting.

#### **CLOTHES & SHOES, USED**

No Fee

Good condition used clothing & shoes – Clothing recycling bins



#### COMMON HOUSEHOLD GARBAGE / MUNICIPAL SOLID WASTE

No Fee

- Must be in white or clear bags.
- Discarded items from your Kitchen and Bath.

#### PROPANE TANKS

No Fee



- Tank MUST be empty and valve stems must be removed
  - Scrap metal.
- 1lbs camp stove tanks can be returned where they are purchased or brought to specified location at SWMC.
  - o Refillable 1lbs propane tanks can be purchased.

#### **RECYCLABLE - PAPER PRODUCTS**

No Fee

- Separate and break down Corrugated Cardboard
- Mixed Paper
  - Newspaper, Magazines, Junk Mail, Office & Computer Paper, Phone Books, Books, Paper-based Gift Paper
- Please remove any packing material in boxes and keep papers loose (no plastic bags, strings or wire)

#### **REFRIGERATORS & APPLIANCES**

No Fee



- Appliances: recyclable item with scrap metal.
- Refrigerators, freezers, AC units & other Freon containing items handled separately, ask the attendant for disposal location.

#### TIRES - CAR & TRUCK Less Than 24"

No Fee



- No Off-The-Road tires. Please remove rims.
- Subject to space availability.
- No more than 15 per customer per day.

#### TV SETS, COMPUTERS MONITORS



• Computers, monitors, televisions

No Fee

Other electronics, including peripherals

SCRAP METAL No Fee



- Remove non-metal portions: wood, fabric, plastic.
- Re move the lids from dry paint cans and other containers.
- Includes: sheet metal, steel, metal cables, empty & dry paint cans, aluminum, tin, copper, metal furniture, appliances (except Freon containing appliances), chain, rods, metal pipe & metal pipe fittings.
