The regular meeting of the Delaware County Board of Supervisors was held Wednesday, October 23, 2024, at 1:00 p.m. in the Supervisors' Room of the Senator Charles D. Cook County Office Building, 111 Main Street, Delhi, New York, Chairman Tina B. Molé presiding.

The Clerk called the roll and all Supervisors were present except Mrs. Scott and Mr. Kosier.

Mr. Smith led the Board in the Pledge of Allegiance to the Flag.

Chairman Molé granted privilege of the floor to Supervisor Cetta. Mr. Cetta introduced Rolland Bojo, CEO of Delaware Valley Hospital and Cindy Ray, Director of Business Development. Mr. Bojo and Ms. Ray had a presentation about the future expansion project at Delaware Valley Hospital an affiliate of UHS. Delaware Valley Hospital has been a health care provider in Walton for over 75 years. They feel that the people of a rural community deserve the same healthcare as people that are in larger locations. After adding more services through the years DVH is now simply out of room to increase services. Delaware Valley Hospital wants to invest in their facility and to the community by creating a Medical Neighborhood. By expanding DVH, they would be able to offer better services to the community. The creation of a Medical Neighborhood would include primary care as well as specialty care which would eliminate the need for traveling far for the same services. There are many advantages of the Medical Neighborhood, such as improved access to care, enhanced care coordination, chronic disease management, preventive care, and community health improvements. It would also be connected to services that are provided throughout the County, as well as a community space for health and wellness activities and support groups. The expansion would take place with no interruption to patient care. The addition of services would help enhance healthcare to the community for another 75 years. Ms. Ray explained the project would require certification of support from local governments and she would be in touch with Supervisors for that.

Chairman Molé thanked Mr. Bojo and Ms. Ray for their vision and all the hard work they have put into this project as well as for their leadership.
