In response to Mrs. Driscoll, Solid Waste Coordinator Tyson Robb explained that there are 2 large capital projects that will be managed out of the Fund 44 account. The first is the first phase of Cell 1 reclamation and redevelopment. This project has been in the works since 2010 and will create new capacity in that area and eventually add 20 years of life to the landfill once completed. This phase is limited in scope to moving the old unlined 1970s waste onto a lined footprint. The next phase, not included in the current scope, will include the design and construction of a new landfill liner over the excavated area. The second project involves the replacement of a large rotating drum in the compost facility that has reached the end of its service life and is in dire need of replacement. The compost facility, although not without potential issues, has served our county well and this capital project is needed to maintain service in the same manner we have for the past 20 years.

Mr. Marshfield commented that the composting facility is a gem to be admired from anywhere. It has been a Godsend for the county. Adjacent counties that are struggling with their solid waste programs still haven't got a grip on things. He stated that a certain amount of the sales tax revenue goes to fund that facility and it's worth every penny. It is a good operation.

Mr. Vernold added that he had toured the facility, it is very impressive and very clean. He would highly recommend to anyone who has not taken the tour to do so.

Mr. Merrill explained that the General Fund contribution from Reserves has been increased by \$500,000 bringing the total to \$7,354,100. This was taken from fund balance to cover projects with the towers that are taken care of by the Department of Emergency Services. This does not change the bottom line. The tax levy is under 2% again for eight years in a row. The tax levy is 1.8356%. Mr. Merrill acknowledged that there is a concern that they did not put anything in the budget for sharing sale tax with towns and villages. He said they are a bit reticent about that as sales tax revenues, for the first time in a couple of years, are declining. As you can see from today's resolution, \$11,000,000.00 that will be used for projects at Solid Waste is an accumulation from sales tax over the years, otherwise that would have raised the budget by 22%. It is those kinds of projects that sales tax has been earmarked for to keep the budget down so every citizen of the County receives the same exact share of sales tax revenue by not having to pay more taxes. The Finance Committee has discussed this at length and would be open to revisiting it at another time. They would like to see what kind of revenues are generated from programs such as Traffic Diversion and how that will affect villages and towns. Mr. Merrill said sharing sales tax is not a dead issue but is not being entertained at this point in this budget.

The resolution was unanimously adopted.

Mr. Cetta gave a shout out to Sheriff Craig Dumond and the Deputy Sheriffs. There was a significant motor vehicle accident in Walton recently which resulted in a double fatality. He thanked the Sheriff's Office for their professional actions and for implementing traffic reconstruction at the scene. It was efficient and timely. Mr. Cetta stated that the reconstruction team is a great asset to the County.

Sheriff Dumond thanked Mr. Cetta, said they are here to serve the Board and the citizens of Delaware County. He thanked the Board for their support.

Chairman Molé asked those wishing to speak to please stand and state their full name and the town they are from. An attendance sheet was passed around for attendees to sign.

Town of Stamford resident Laurie Zeh stated that she feels these raises are a little inflated for what the cost of living is. The increase for social security recipients is going to be 2.3% based on the rate of inflation. She expressed that the raises should be evaluated, not only for the cost of living, but based on performance reviews also. Ms. Zeh asked the Board to consider long-term effects and how it will affect future spending with increased expenses such as increased pensions when people retire.

Town of Kortright resident Joanne Harrington stated that when some of these County Officers got a raise in the past, she called her representative who told her that these people work really hard. She acknowledged they probably do, but so do a lot of people who live in this County. She stated that she asked her representative what the average income was in the county and said his reply was that he was not sure. She guessed it would be around \$30,000.00 per year. She said we are talking about people who get a salary, health care, retirement...good benefits. She is not saying that they don't work hard, but she does not believe they would leave if they did not get a raise, and she does not believe the County would have a hard time replacing them if they did leave. She does not feel that these raises are warranted at this time.

Chairman Molé thanked those that spoke.
